Supporting Information

From September 2004 thru August 2009 the University of Houston-System component universities (University of Houston, University of Houston-Clear Lake and University of Houston-Downtown) have contracted with CORESTAFF Services for on-site staffing services. CORESTAFF Services was selected as a result of the Competitive Sealed Proposal (CSP) process and CORESTAFF Services submitted the best value in quality, service and their full range of job types. The services included providing qualified temporary employees in a timely and cost-effective manner, and to coordinate the ordering of any temporaries not available from its own employee pool with other suppliers, including minority owned/women owned business enterprises. The annual temporary services staffing expenditures for FY2008 totaled \$2, 216,607.83.

An RFP for Temporary Services (730-TEMP09) was prepared by the UH Purchasing Department and posted to the State of Texas Electronic State Business Daily on April 8, 2009. The document requested a proposal for services for a 24-month period from September 1, 2009 and continuing through August 31, 2011 and included a provision to renew the agreement effective September 1, 2011 for twelve months for a maximum of three renewal periods.

In accordance with the state of Texas policy of encouraging the use of Historically Underutilized Businesses (HUBs) in state procurement, the University of Houston shall make a good faith effort to utilize HUBs in contracts for construction, goods and services. The RFP required any business that contract with the University of Houston to make a good faith effort to award necessary subcontracts to HUBs in accordance with Texas Procurement and Support Services Rule 111.13(b) and SB 178. CORESTAFF Services HUB plan is to subcontract 30% of the total bid amount.

A pre-proposal conference was held on campus on April 16, 2009. The University was represented by UH Purchasing Department and a total of 10 companies attended the conference. One addendum was issued.

RFP were received and closed (opened) on May 22. Eighteen responses were accepted, four were not accepted for various reasons. At least two providers were refused submission as they were too late for the deadline.

All acceptable responses were provided to the UH evaluation team which met over a period of weeks to make a determination. This group evaluated the responses based on the evaluation

criteria established in the RFP. The evaluation team settled on three providers as final candidates and scheduled presentations/meetings with each. Finally, this team determined that CORESTAFF Services, based in Houston Texas, was the best overall choice for temporary services for the University of Houston.


This proposal would sell METRO 2.01 acres and 13 tracts of the University of Houston land on Wheeler Avenue to METRO at fair market appraised value, (\$1,342,864.00--\$15.29/sf) for right of way for development of the Southeast Corridor light rail line. Located on the south side of Wheeler Avenue between Calhoun Street and Cullen Blvd., these 13 tracts are residential lots in the University Oaks subdivision on the south perimeter of campus.

METRO will acquire the remaining lots in this stretch of Wheeler Avenue to secure a continuous strip of land to accommodate the installation of the Southeast Corridor light rail line and station. The Wheeler Avenue corridor will be redeveloped to include a UH private inner campus drive, the rail line and station and Wheeler Avenue, designed as a four lane boulevard thoroughfare. Campus access and circulation has been protected in this plan.

The University benefits from this proposal as it receives a significantly enhanced southern border and gateway, a landscaped buffer with University Oaks neighborhood and dramatically improved transportation and connection to the City and region.

Note this proposal does NOT include other UH property Metro is requesting along Scott or in any other locations. There are major issues with those potential purchases and they are not included in this agenda item. When those issues are resolved a separate agenda item will be submitted to the Board of Regents.





Location:

These 13 scattered tracts are located on the south side of Wheeler Avenue in the University Oaks neighborhood. These lots were acquired by UH to protect its campus perimeter, are not integral to development and were not included in the Campus Framework Plan.


Purpose:

METRO will acquire a continuous strip of land between Calhoun and University Oaks Blvd. for development of a new corridor between UH Campus south boundary and future north boundary of University Oaks after taking the entire first row of lots.

While this corridor configuration was negotiated between METRO and the University Oaks Neighborhood Association it is attractive to the University. The private drive (Existing Wheeler) becomes an integral part of UH Shuttle bus routes and protects access to the 6 driveways now located on Wheeler. Also, the "East University Rail Station" will be adjacent to UH campus, facilitating integration of the UH Cougar Line campus shuttle bus, pedestrian circulation and access to the student housing.

Land and Value:

The 13 tracts include 2.01 acres (87,839 sf) of land which have a fair market value based on appraisals of \$1,342,864.00 representing \$15.29 / per square foot. This is similar to values in the area. METRO will pay this amount as well as all expenses associated with due diligence. Though subject to final evaluation METRO's preliminary due diligence indicates there are no environmental or other issues that will impact the terms and conditions of sale,. In addition the properties cost, UH \$504,195.86 to purchase vs. the proposed purchase price of \$1,342,864.00-- a net gain of \$838,688.14.

Lease/Operating Agreement

Bay Area Houston Economic Partnership

The Parties

The University of Houston-Clear Lake is one of four universities within the University of Houston System. UHCL is an upper level and graduate institution serving over 7,600 students and is located in Bay Area Houston adjacent to NASA's Johnson Space Center.

Bay Area Houston Economic Partnership is a 501(c)(6) non-profit organization that provides leadership to stimulate regional economic development and employment in Bay Area Houston. The organization's membership includes thirteen cities, two counties, and over 250 members.

Bay Area Business and Technology Center

The Bay Area Business and Technology Center is a collaboration between the University of Houston-Clear Lake and the Bay Area Houston Economic Partnership for the purpose of enhancing the economic development and quality-of-life of the region through workforce development and technology transfer. In addition, partnerships between and among educational institutions, business organizations, and government agencies focus on the development of academic programs, research, and community outreach to enhance the educational levels and economic development of the region.

Federal Grant

UHCL was informed in late 2005, that funds had been awarded to the U.S. Department of Housing and Urban Development, through its Economic Development Initiative funds, for a grant to UHCL for construction of a facility for the Bay Area Business and Technology Center. During 2006, the application for funds process was completed. The final notice of grant approval was received in early 2007. The purpose of the grant is to significantly advance regional collaborations by providing a common educational and business facility located on the campus of UHCL for multiple partners to accomplish regional education, training and economic development goals. The original request for funding was a joint effort of BAHEP and UHCL. The amount of the grant is \$990,000.

Current Activities

The formation of the Bay Area Business and Technology Center was an outgrowth of previous collaborations between BAHEP, UHCL and the University of Houston System, as well as planned future partnerships. Through the University of Houston System, BAHEP currently receives state funding for the Technology Outreach Program (TOP) which focuses on the use of technology from the aerospace program to benefit small businesses. TOP includes business and university participants including UHCL. BAHEP has also worked closely with UHCL's Center for Economic Development and Research.

UHCL works closely with BAHEP on technology and education issues via BAHEP committees including the Aerospace Advisory Committee, the Education and Workforce Development Committee, the International Business Development Committee and the International Maritime Advisory Committee. UHCL has also partnered with BAHEP on state grants including a grant from the Texas Workforce Commission for the Aerospace Workforce Innovation Network, which was awarded in 2007. Close working relationships have been established between BAHEP and UHCL's School of Business and School of Science and Computer Engineering.

UHCL continues to work with BAHEP on educational programs related to science, technology, engineering and mathematics. Previous projects have included the development of academic programs in biotechnology, computer engineering, engineering management, physics, software engineering and systems engineering. One project of special note is the collaborative doctoral program in physics which is a UH and UHCL partnership.

Lease/Operating Agreement

The Bay Area Business and Technology Center will be constructed on the campus of the University of Houston-Clear Lake. The facility, built with the grant funding from the U.S. Department of Housing and Urban Development, will be 6,150 gross square feet. The operating costs of the facility and property, including utilities, building maintenance, custodial services, grounds, security, and a capital renewal fund will be paid by the Bay Area Houston Economic Partnership.

The agreement will be for 10 years with an option for an additional 10 years.

Project Project Overview

As a cost effective strategy the University of Houston-Victoria proposes to acquire an existing Victoria hotel property and redevelop and renovate it as an Academic Services Center and Residence Hall.

Candidate Properties

There are several properties under consideration with potential to meet UHV requirements. One of the candidates is within 4 blocks of campus and contains up to 226 rooms, meeting space, dining and related hotel facilities and parking. The other is within 2 miles of campus and contains up to 126 rooms, related hotel facilities and amenities and parking. Market availability, pricing, property condition and transaction terms and conditions will determine which property is selected. The proforma business plan is based on the largest project, and can be scaled back if a smaller facility is selected.
